God, in His goodness led me to stay with a former close friend named Lynn Hudson Morgan whom I used to work with on the ship Doulos, 34 years ago. Lynn and her husband have been taking great care of me in many ways. I am thankful to the Lord for His goodness and provision.

The second Avastin shot that I had during the first week of June, brought a lot of improvement to my eyesight. I am grateful to the Lord for providing me with a good and kind ophthalmologist who has been treating me free of charge. On July 7, I had a third shot and hopefully my eyesight will continue to heal with the same great improvement.

God's sovereign plan is always far beyond my comprehension; He wonderfully orchestrated a change for the Thailand Women's Ministry (TWM). Prior to the end of March, I had been informed that a change of clearinghouse was needed. At first, I was a little shocked, but even so, I immediately sought God's will. I wanted to do what was right in God's eyes and in obeying the Internal Revenue Service in the US. God, answered my prayer very specifically by introducing me to Advancing Native Missions (ANM) this past April.
